PERSONNEL RESOLUTION 1

1. It is the judgment of the West Long Branch Board of Education that teacher 2021-1 shows deviation from normal mental health and is required to submit to an individual psychiatric examination pursuant to N.J.S.A. 18A:16-2. The reason for this directive is that, as a result of information made available to the Board, it has been determined that the teacher has engaged in conduct affecting the teacher's ability to teach, discipline or associate with children of the age of the children subject to the teacher's control in the West Long Branch School District. As mandated by N.J.A.C. 6A:32-6.3, paragraph (b)1, teacher 2021-1 shall be provided with a written statement of reasons for the required psychiatric examination and a hearing if requested. Pending the psychiatric examination and further action of the Board, teacher 2021-1 shall continue on administrative leave with pay.
